



Wisconsin's Economy Depends on Worldwide American Companies

Wisconsin's 675 worldwide American companies and their employees need a level international playing field to prosper and grow. These companies support substantial employment and economic output in Wisconsin, directly through their production of goods and services, through their suppliers, and through spending by the people they employ.

If the Congress raises international taxes on worldwide American companies – while other nations are adopting more competitive tax structures – it will put Wisconsin companies and their employees at a competitive disadvantage with their foreign competitors and jeopardize the substantial contributions they make to Wisconsin's economy.

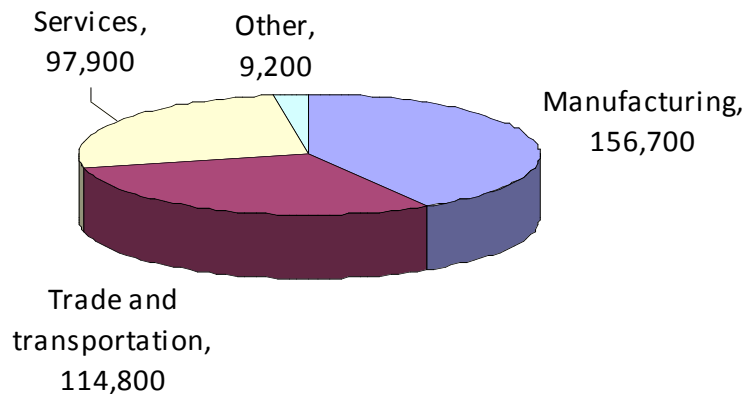
*The direct contribution consists of employment in and the payroll and production of worldwide American companies in the state.

**The indirect contribution consists of employment, payroll, and production supported by worldwide American companies through their supply chains and the consumption spending of the people they employ directly or indirectly.

- In 2007, worldwide American companies in Wisconsin employed **378,500** people and supported an additional **850,500 jobs** through their supply chains and spending by the people they employed directly or indirectly.
- These jobs accounted for **39.3 percent** of all private-sector employment in Wisconsin and **43.3 percent** of the total private-sector payroll in the state.
- Worldwide American companies in Wisconsin create high quality jobs, paying on average **\$55,955 per worker** in wages and salaries and fringe benefits in 2007.
- Worldwide American companies in Wisconsin accounted for **46.2 percent** of Wisconsin's GDP (\$92.9 billion) in 2007.
- Worldwide American companies also paid approximately **\$2.8 billion** in dividends to Wisconsin residents in 2007.

Direct Employment by Worldwide American Companies in Wisconsin by Industry

Worldwide American companies employed **378,500** Wisconsin workers in 2007 in a wide range of industries, including the following:



Trade and transportation: 302 companies, 114,800 jobs

Manufacturing: 301 companies, 156,700 jobs

- Food: 25 companies, 19,100 jobs
- Commercial and service industry machinery: 50 companies, 18,000 jobs
- Paper: 19 companies, 15,700 jobs
- Other manufacturing: 250 companies, 104,000 jobs

Services: 294 companies, 97,900 jobs

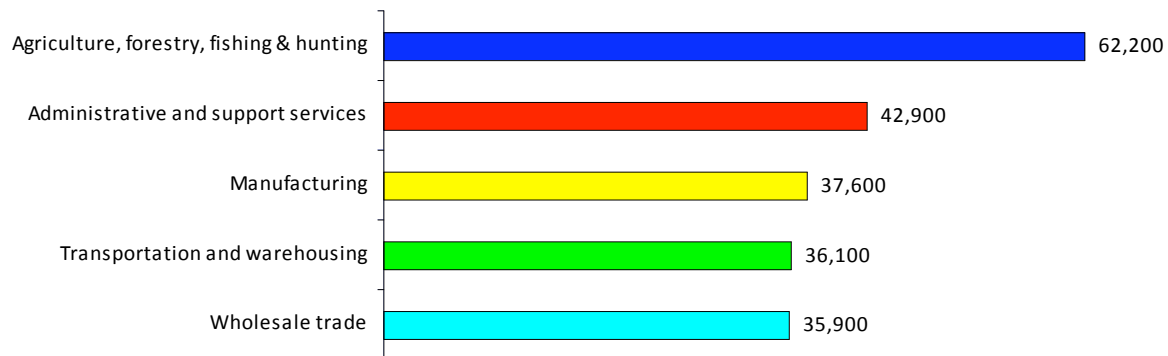
- Administrative and support services: 71 companies, 28,600 jobs
- Internet, data processing: 12 companies, 11,400 jobs
- Food services: 17 companies, 9,000 jobs
- Other services: 238 companies, 49,000 jobs

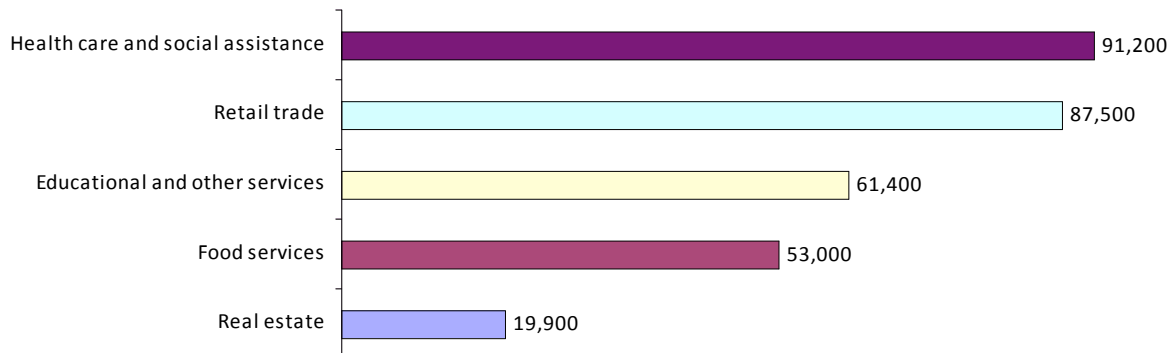
Indirect Employment through Purchases of Goods and Services from Suppliers
